The Challenge

VicTrack's Telecommunications business aspires to be certified to ISO55001. To initiate the process, VicTrack faced these challenges:

- AMPs needed to be developed; Maintenance needs were not clear.
- The telecommunications business is a highly complex environment with a mix of customer products, defined services and network platforms that are used interchangeably;
- Traditional asset management document structures do not work well in this complex environment and it has been difficult to establish a documentation structure.

As a result, the new structured asset management approach was needed to understand the current Asset Management System (AMS) and determine the most effective way to improve asset performance, which eventually achieves the desired outcomes of the organization.






The Solution
